ARTICLE I - NAME

The name of this Corporation is Idea Men Group, Inc. and the address is 449 N. Thompson Road, Apopka, Florida 32712.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS
