### ARTICLES OF INCORPORATION OF

ARTICLE I Corporate Name

The name of this corporation is: RS Investments, Inc..

## ARTICLE II Nature Of Business And Powers

The general nature of the business to be transacted by RS Investments, Inc. is to engage in any and all business permitted under the laws of the State of Florida.

## ARTICLE III Capital Stock

The maximum number of shares of stock that RS Investments, Inc. is authorized to issue and have outstanding at any one time is 1000 shares of common stock without par value.

## ARTICLE IV Term Of Existence

RS Investments, Inc. shall have perpetual existence, commencing upon filing of these articles.
