To whom it may concern:

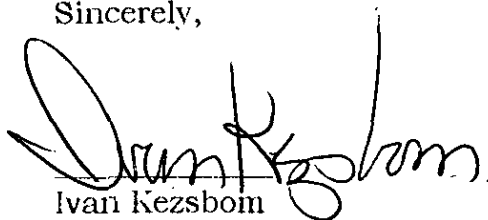
I apologize for the lateness of this report. I called and spoke with a representative of your office who was quite sympathetic and suggested that I write and ask for an exception.
