ARTICLE I - NAME

The name of this corporation is *GATOR-PHILLIPS PRINTING, INC.*

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the laws of the United States and of this state.

ARTICLE IV - ADDRESS OF CORPORATION

The street address of the principal location of the Corporation is 13005 Spring Hill Drive, Spring Hill, FL 34609.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of Common Stock at \$1.00 par value.

ARTICLE VI - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the shareholders.


ARTICLE XI - AMENDMENT
