ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation.

ARTICLE ONE

The name of the corporation is Miami Dental Alliance of South Florida, Inc.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To engage in the practice of dentistry, providing for the diagnosis, care and treatment of patients in said area of dentistry.
- 2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
