## ARTICLES OF INCORPORATION

Price Carpentry, Inc.

We, the undersigned, hereby associate ourselves together and make, subscribe, acknowledge and file these Articles of Incorporation with the Secretary of the State of Florida for the purpose of becoming a corporation for profit under the Laws of the State of Florida.

Article I.

The name of the Corporation shall be:

Article II.

The principle place of business and mailing address of the Corporation, at least initially, shall be:

## Article VI.

The general nature of the business to be transacted by this corporation shall be as follows:

- (a) To engage in the construction, repair, and remodeling of buildings, and for the improvement of real estate, and the doing of any other business and contracting work incidental to or connected with such work.
- (b) To buy, sell, manufacture, repair, alter and exchange, let or hire, export, and deal in all kinds of articles and things which may be required for the purpose of any said businesses, or commonly supplied and dealt in by persons engaged in any such business, or which may seem capable of being profitably dealt with in connection with any of the said businesses.
- (c) To manufacture, purchase, or otherwise acquire, and to mortgage, pledge, sell, assign, and transfer or otherwise dispose of, and to invent, trade, deal in and deal with goods, wears, merchandise, and other personal property of every class and description whatsoever.
- (d) To guarantee, to acquire by purchase, subscription or otherwise, hold for investment or otherwise sell, assign, transfer, mortgage, or otherwise dispose of the shares of capital stock or, any bonds, securities or evidences of indebtedness, to exercise all rights, powers and privileges of ownership, including the right to vote thereon for any and all purposes; to aid by loan, subsidy, or guaranty, or in any other manner whatsoever so far as the same my be permitted in the case of incorporations, organized under The General Corporation Laws of The State of Florida, any corporation whose stocks, bonds, securities, or other obligations are or maybe in any manner and other acts or things for the preservation, protection, improvement or enhancement in value of such stocks, bonds, securities, or other obligations; and to do all and any such acts or things designed to accomplish any such purpose.
- (e) To act as financial, business, and purchasing agent for domestic and foreign corporations, individuals, partnerships, associates, state governments, and other bodies.
- (f) To borrow money and contract debts when necessary for the transaction of its business or for the exercise of it's corporate rights, privileges, franchises, or for any other lawful purpose of its corporation; to issue bonds, promissory notes, bills of exchange, debentures or other obligations and evidences of indebtedness as payable at a specified time or times, or payable upon the happening of a specified event or events, secured and/or unsecured, from time to time, for monies borrowed, or in payment for the property acquired, or for any part of the objects of its business; to secure the same by mortgages, or deeds of trust or pledge or other lien upon any or all the property, rights, privileges, or franchise of the corporation, whatsoever situated, acquired or to be acquired; and to confer upon the holders of any debentures, bonds, or other evidences of indebtedness of the Corporation, secured or unsecured, the right to convert the principle thereof into any preferred common stock of the corporation, now or hereafter authorized upon such terms and conditions as shall be fixed by the Board of Directors; to sell, pledge or otherwise dispose

of any or all debentures or other bonds, notes, and other obligations in such manner and upon such terms as the Board of Directors may deem judicious, subject however, to the provisions of Article VI hereof.

(g) To purchase, sell and transfer shares of its own capital stock.

(h) To do all and everything necessary and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers enumerated in these Articles of Incorporation or any Amendment thereof, necessary or incidental to the protection and benefits of the corporation, as principle, agent, director, trustee, or otherwise and in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful business necessary or incidental to the accomplishment of the purposes or the attainment of the objects set forth in these Articles of Incorporation or Amendment thereof.

The foregoing paragraphs shall be construed as enumerating both objects and powers of the corporation; and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the powers of this Corporation.
