

**ARTICLES OF INCORPORATION
OF
Lawrence L. Fleckinger, P.A.**

ARTICLE I - NAME

The name of this corporation is Lawrence L. Fleckinger, P.A.

ARTICLE II - TERM OF CORPORATE EXISTENCE

This corporation shall exist perpetually unless dissolved according to law and such existence shall commence at the time of filing of these Articles of Incorporation by the Department of State.

ARTICLE III - CORPORATE PURPOSE

The nature of the professional service to be rendered by this corporation is the practice real estate brokerage, management, sales, purchase services and all related business necessary thereto, and any other activity of business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - AUTHORIZED SHARES

The aggregate number of shares which the corporation shall have the authority to issue is 1,000 shares of Common Stock with a \$1.00 par value per share. It is intended that stock issued by this corporation shall be in accordance with Sect 1244 of the Internal Revenue Code of 1986 as amended.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof at the same price at which it is offered to others.

ARTICLE VI - REGISTERED AGENT

The initial registered office of the corporation is located at *4900 Hidden Pines Place, Cocoa, Florida 32926*. The principal office and mailing address are at the same address. The initial registered agent is Lawrence L. Fleckinger.

ARTICLE VII - DIRECTORS

The business shall be managed by a Board of Directors consisting of not fewer than one person, the exact number to be determined from time to time in accordance with the by-laws.
