ARTICLES OF INCORPORATION

OF

PRECIOUS L'IL PRINTS, INC.

ARTICLE I - NAME AND ADDRESS

The name of this corporation is **PRECIOUS L'IL PRINTS, INC.** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 1839 Adams Street, Hollywood, Florida 33020.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which the Corporation shall have authority to issue is One Thousand (1,000) shares of common stock, all of which are to have a par value of One Cent (\$.01) per share. ARTICLE X - AMENDMENT


