## WESCOTT'S WOODWORKING, INC. ARTICLES OF INCORPORATION

The undersigned, acting as incorporator under and by virtue of the laws of the State of Florida, and particularly the Florida General Corporation Act, as provided in Chapter 607, Florida Statutes, and any act supplementary thereto, adopts the following Articles of Incorporation for such corporation.

ARTICLE I The name of the corporation shall be: WESCOTT'S WOODWORKING, INC. and its principle office and mailing address shall be: 1431 SW 1st Avenue Ft. Lauderdale, Fl. 33315.

ARTICLE II The location of its initial registered office in the State of Florida is 1431 SW 1st Avenue, Ft. Lauderdale, Fl. 33315, but it shall have the power to establish and maintain branch offices at such cities and towns in the State of Florida and the United States as said corporation may from time to time determine. The name of its initial registered agent at said address is John Schreiber
