Thank you for taking the trouble to telephone me this evening regarding the worrying situation about Yorkshire & Associates. I understand you have spoken to the Division Of Corporations about the fact that my 2000 Business Report has not yet been filed. As I explained to you, I sent the Annual Report with my cheque for \$150 to Arthur Wrigglesworth, who was my longtime fellow countryman and business advisor in Florida and who was going to file the Report, in accordance with my instructions. Unfortunately, I found out in June when I called his office that he had tragically died and his business had closed as a result of his death. My letter of instructions, completed Annual Report and cheque for \$150 were found on his desk, not having been sent to the Division of Corporations in Florida, and that you now say I have to pay an extra \$300 because of his untimely death.

When I spoke to you in early August, I am pleased that you suggested I send everything to you to sort out otherwise I believe the company will be dissolved later this month by the Division of Corporations.

Please enclose the original cheque dated April 17th which was returned to me by the office staff of my late business advisor and plead with the Division of Corporations for a waiver of the extra fee for filing the Annual Report. I now would like you to deal with all my affairs concerning Yorkshire & Associates as you are resident in Florida and are fully conversant with the Florida company laws. I find it so frustrating not to be in control of the situation due to the distance between the UK
