## ARTICLES OF INCORPORATION

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit in accordance with Chapter 607, Florida Statutes as applicable.

### ARTICLE I

The name of the corporation shall be

FACILITY SAFETY SYSTEMS, INC.

### ARTICLE II

The purpose for which this corporation is formed is to provide governmental relations.

### ARTICLE III

The address of the initial registered office of the corporation is 101 North Gadsden Street, Tallahassee, Florida 32301, and the name of its initial registered agent at such address is Robert F. Reyes. Principal address is same as registered address.

### ARTICLE IV

The period of this corporation's duration is perpetual existence.

### ARTICLE V
