In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is FAREAST SPORTS MANAGEMENT, INC.

ARTICLE II

The existence of the corporation shall begin on March 4, 1999.

ARTICLE III

The purpose for which the Corporation is formed is to own, maintain and operate sports management and marketing business; and to engage in any other lawful purpose and business.

ARTICLE IV

The street address of the principal office of the corporation is 800 N. Ferncreek Ave. Suite 8, Orlando, Florida 32803.

ARTICLE V

The maximum number of shares this corporation is authorized to issue is 20,000 with \$1.00 par value, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

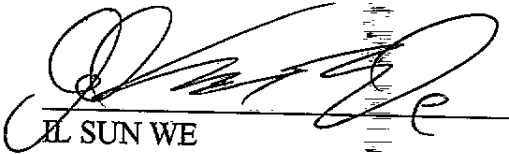

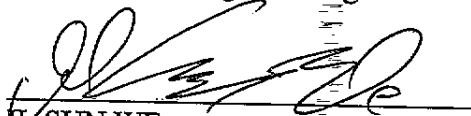
DESIGNATION AND ACCEPTANCE OF REGISTERED AGENT
