ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME OF THE CORPORATION

The name of the Corporation is E-AN Trading USA, Inc.

ARTICLE II

ARTICLE III

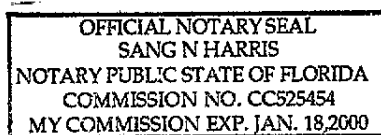
