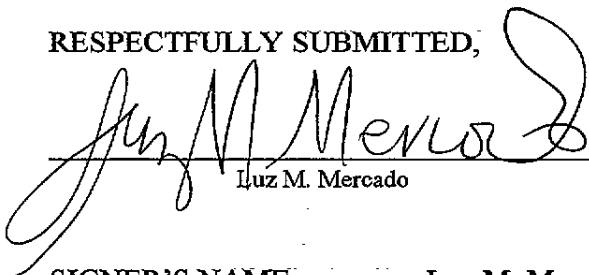

ARTICLE I NAME

The name of the corporation shall be DATA MEDICAL BILLING, INC.
