ARTICLE I - NAME

The name of this corporation is PUGH & VAN BUREN, P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Secretary of State, State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of practicing law and all activities normally included therewith, including operating a law office, advising and representing clients, and such other lawful public business as may be permitted by the Statutes of the State of Florida.

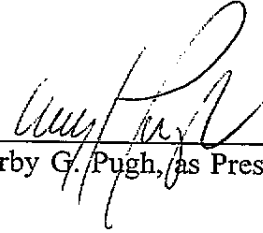
ARTICLE VIII - BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the Shareholders.

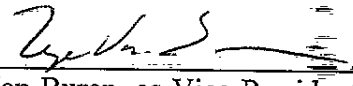
ARTICLE IX - AMENDMENT

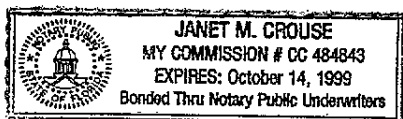

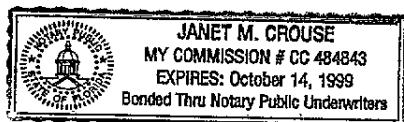

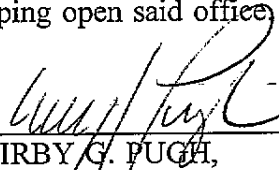
