The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

Corporation or until he resigns or his successor is elected or appointed and qualified, whichever occurs first.


