ARTICLES OF INCORPORATION OF PEPPERTREE SIESTA, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is PEPPERTREE SIESTA, INC.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. CAPITAL STOCK
