## AMENDMENT TO THE ARTICLES OF INCORPORATION OF SUN SUM AT ABACOA, INC.

Article IV of the Articles of Incorporation of SUN SUM AT ABACOA, INC., a Florida corporation, is hereby amended to read as follows:

## ARTICLE IV - CAPITAL STOCK

The Corporation is authorized to issue two (2) classes of stock. The Corporation is authorized to issue FIVE THOUSAND (5,000) Shares of \$1.00 par value class A voting common stock, which shall be designated "Class A Common Shares", and FIVE THOUSAND (5,000) Shares of \$1.00 par value class B non-voting common stock, which shall be designated "Class B Common Shares". Class A Common Shares shall have unlimited voting rights on all matters voted on by the shareholders of the Corporation. Class B Common Shares shall have no voting rights, except to the extent prohibited by law. Class A shares and Class B shares shall be equally entitled to receive the net assets of the Corporation upon dissolution.

The foregoing Amendment to the Articles of Incorporation of SUN SUM AT ABACOA, INC., a Florida corporation, was approved and adopted by written unanimous consent of all the directors and the stockholders of the Corporation on the 4<sup>th</sup> day of August, 1999, in accordance with the authority contained in Section 607.181(3), Florida Statutes.


