ARTICLES OF INCORPORATION

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE, Tinta 2000 Inc.

ARTICLE II
