

I. NAME

The name of the corporation is GLOBAL MEDIA MARKETING, INC.

II. TERM OF EXISTENCE

X. AMENDMENTS

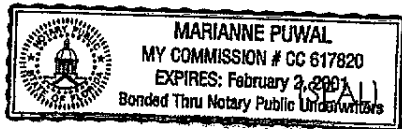




