ARTICLES OF INCORPORATION  
OF

(A STOCK CORPORATION)

FIRST: The name of the corporation is Mariners' Group International, Inc.

SECOND: The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida, other than banking business, the trust company business or the practice of a profession permitted to be incorporated by the Florida Corporation Code.

THIRD: The name and address in this state of the corporation's initial agent for service of process is Florida Filing & Search Services, 3260 Baldwin Drive West, Tallahassee, Florida 32303.

FOURTH: The corporation is authorized to issue only one class of shares of stock which shall be designated common stock. The total number of shares it is authorized to issue is 100,000 shares.



SEVENTH: The corporation is authorized to indemnify the directors and officers of the corporation to the fullest extent under Florida Law.




