The undersigned Incorporator hereby files these Articles of Incorporation in order to form a Corporation under the laws of the State of Florida, effective at the time of filing.

ARTICLE I. Name and Principal Office

The name of this Corporation shall be MASON'S SCHOOL OF MUSIC, INC. The principal place of business and mailing address of this Corporation is 3309 Robinhood Road, Tallahassee, Florida 32312.

ARTICLE II. Nature of Business
