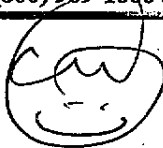

Pursuant to the provisions of Sections 607.1001 and 607.1006 of the Florida 1989 Business Corporation Act, the following Articles of Amendment to the Articles of Incorporation of Carlander.com, Inc., a Florida corporation ("Corporation"), are hereby adopted:

FIRST: The name of the Corporation is Carlander.com, Inc.

SECOND: Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"ARTICLE I

The name of the Corporation is Carlander, Inc."

THIRD: The above designated amendment does not provide for an exchange, reclassification or cancellation of issued shares of stock of the Corporation.

FOURTH: The designated amendment was adopted by the Corporation's Board of Directors by written consent on August 22, 2000, and submitted for approval by the Corporation's shareholders. The Corporation has 100 outstanding shares of common stock, having \$.01 par value per share, and each such share was entitled to one vote on the amendment. The proposed amendment was adopted by the shareholders of the Corporation by written consent on August 22, 2000, such consent being sufficient for approval of the amendment.
