ARTICLES OF INCORPORATION SECRETARY OF STATE OF GLOBAL NET IMPORT/EXPORT, INCALLARASSEE, FLORIDA

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I -- NAME
