## ARTICLES OF INCORPORATION

OF

The undersigned, being an individual, does hereby as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name for the corporation (hereinafter called the "Corporation") is Kinsella Holding Corp.

SECOND: The address, wherever located, of the principal office of the Corporation, if known, is 3706 Palma Ceia Court, Tampa FL 33629.

NINTH: Whenever the Corporation shall be engaged in the business of exploiting natural resources or other wasting assets, distributions may be paid in cash out of depletion or similar reserves at the discretion of the Board of Directors and in conformity with the provisions of the Florida Business Corporation Act.
