ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be J & G NURSERY, INC., with its principal place of business at 19121 East Pennsylvania Avenue, Dunnellon, Florida 34432.

ARTICLE II - NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States of America, the State of Florida, or any other state, territory, country, or nation.

ARTICLE III - CAPITAL STOCK

**ARTICLE VI - BOARD OF DIRECTORS**


