ARTICLES OF INCORPORATION

FLORIDA STATE BLINDS, INC.

The undersigned incorporator hereby forms a corporation under chapter 607 of the laws of the State of Florida.

ARTICLE 1- NAME

The name of this corporation is FLORIDA STATE BLINDS, INC.

ARTICLE 2- PRINCIPAL OFFICE

The street address of the initial principal office of the corporation shall be: 3690 N W 16TH Street, ILauderhill, FL 33311

ARTICLE 3- PURPOSE

The corporation is organized for the purpose of installation of blinds or in any activity permitted by this State or the United States.

ARTICLE 4- CAPITAL STOCK

This corporation is authorized to issue one thousand(1,000) shares of one dollar(\$1.00) par value common stock which shall be designated as "common shares".

ARTICLE 5- INITIAL REGISTERED AGENT AND OFFICE




