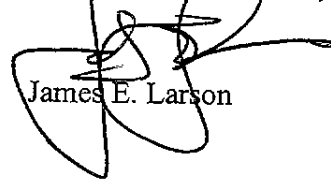

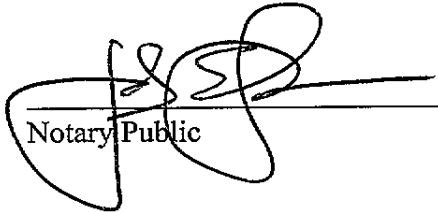
1. The current name of the corporation is Sterident, Inc.
