The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Wizard Concrete Cleaning, Inc.  
The address of the corporation is 15-A Crossing Circle, Boynton

ARTICLE II - TERM OF EXISTENCE

The duration of the corporation is perpetual

ARTICLE III - NATURE OF BUSINESS

The general purposes for which the corporation is organized are:

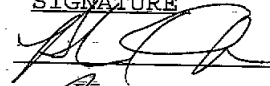
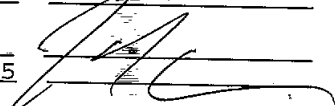

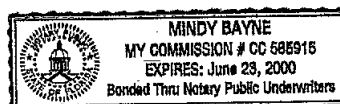
