#### ARTICLES OF INCORORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I NAME AND ADDRESS

The name of the corporation is Advanced Imaging of Winter Park, Inc. The principal office of the Corporation and its mailing address is 3117-B Edgewater Drive, Orlando, Florida 32804.

### ARTICLE II CORPORATE DURATION

The duration of the corporation is perpetual.
