ARTICLES OF INCORPORATION

of

ARTICLE I - NAME

The name of the corporation is ----- NEW CONSTRUCTION CLEANING INC. and whose principal office location is 1219 ABBEY CRESCENT LANE

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE
