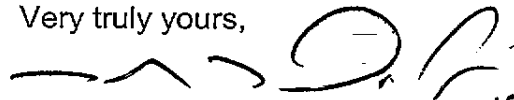

ARTICLE I - NAME

The name of the Corporation shall be **Noah & Co. Builders**, with its principal place of business located at **1701 S.E. 14th Street, Ft. Lauderdale, Florida 33316**.

ARTICLE II - DURATION

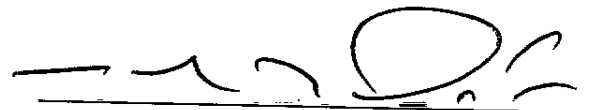

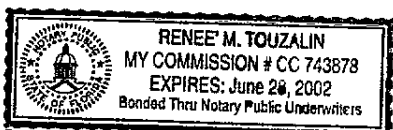

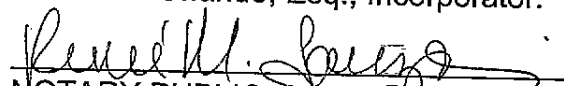
