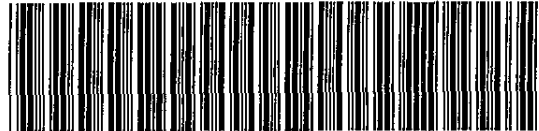

Treasurer: Orlando Vega


whose addresses shall be the same as the principal address of the Corporation.
