Article I-Name

The name of this corporation is HODGES, AVRUTIS & PRETSCHNER, A Professional Association.

Article II-Duration

This corporation shall have perpetual existence.

Article III-Purpose

This corporation is organized under Chapter 621, Florida Statutes (1997) for the sole and specific purpose of rendering professional legal service and shall have as its shareholders only other professional corporations, professional limited liability companies, or individuals who themselves are duly licensed to render professional legal services in the State of Florida.

Article IV-Capital Stock

This corporation is authorized to issue 1,000 shares of one (\$1.00) dollar par value common stock.

Article V-Preemptive Rights

There shall be no preemptive rights.

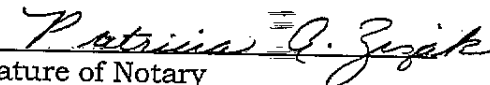
