Enclosed you will find the *Employer Registration Form* for Precision Surfaces, Inc. Also included are "pro-forma" UCT-6 forms for the 2nd, 3rd, and 4th quarter of 1999.


Precision Surfaces, Inc. was incorporated on 3/15/99 in Florida and began business in May of 1999. The officers of this corporation have never operated a corporation before nor paid regular wages. They did timely file their federal forms for the year, properly making their payroll deposits. However, having previously operated as a sole proprietorship, they were unaware that officer-employees were subject to unemployment compensation tax. They were made aware of their obligation when we prepared their year end W-2 forms; they brought in the federal 940 EZ form at that time.

We would like to get them registered at this time. They would appreciate your doing the necessary computations for current and past tax due and sending them a bill for any balance due. A check is included for the estimated tax due.

At this point we respectfully request abrogation of any late filing and paying penalty for the previously unfilled quarters. They have made every attempt to meet their payroll reporting obligations, but due to lack of previous experience, they were unaware of the Florida reporting/tax requirements. As a new corporation, they are not yet operating profitably and have not been able to pay wages on a regular basis; hence the lack of any wages paid during the 3rd quarter. As of 1/1/2000 they have contracted with a leasing company for their payroll needs so they will no longer be responsible for payroll reporting.

Enclosed you will find the Uniform Business Report for Precision Surfaces, Inc.


Tuesday, July 18, 2000, I received the enclosed 2000 Uniform Business Report.
