ARTICLES OF INCORPORATION OF <u>RENAITRE, INC.</u>

THE UNDERSIGNED, acting as sole incorporator of RENAITRE///INC. (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA") hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I Name

The name of the Corporation is:

RENAITRE, INC.

ARTICLE II Business and Activities

The Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III Shares

The total number of shares which the Corporation shall have the authority to issue shall be ONE HUNDRED THOUSAND (100,000) shares of Common Stock having a par value of \$0.01 per share.

ARTICLE IV <u>Preemptive Rights</u>

No shareholder of the Corporation shall have any preferential or preemptive right to subscribe for or purchase from the Corporation any new or additional shares of capital stock or securities convertible into shares of capital stock, of the Corporation, whether now or hereafter authorized.
