The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Rain Coat Waterproofing Company.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on March 15, 1999 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

The number of directors may be increased or decreased from time to time thereafter according to the bylaws of the corporation but shall never be less than one. 
ARTICLE VIII - SHAREHOLDER PROPERTY

The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.


