ARTICLES OF INCORPORATION OF PENN-HAR, INC.

SECONDA SECOND

The undersigned, for the purpose of forming a corporation, for profit, files these Articles of Incorporation with the Secretary of State of the State of Florida, pursuant to the Florida Business Corporation Act of the State of Florida, Chapter 607, Florida Statutes.

- 1. **NAME.** The name of the corporation is PENN-HAR, INC. (the "Corporation").
- 2. **ADDRESS.** The street address and the mailing address of the initial principal office of the Corporation is 4412 E. Columbus, Tampa, FL 33605.
