ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation shall be Ashmore Vacation Homes Management, Inc.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State, Division of Corporations. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of the selling of Real Estate, and engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States Of America.

ARTICLE IV. CAPITAL STOCK

Articles Of Incorporation Of Ashmore Vacation Homes Management, Inc. This corporation shall have the authority to issue 7,500 \$1.00 par value shares of common capital stock.

<u>ARTICLE V. PREEMPTIVE RIGHTS</u>
