ARTICLES OF AMENDMENT
OF
IGORMANIA, INC.

The undersigned incorporator, a natural person competent to contract, hereby presents these Articles of Amendment to the Articles of Incorporation of the Florida corporation herein stated below.

Pursuant to Florida Statute 607.1005, the undersigned incorporator makes the following amendments to the corporation's initial Articles of Incorporation.

The following Amendments to the Original Articles of Incorporation shall take effect as soon as allowable by law.


Amendment I

ARTICLE III - CAPITAL STOCKS

Add the following sentence after the first sentence of paragraph one:

"Of the 10,000 outstanding shares, 2000 of said shares shall be "Voting Shares" and 8,000 shall be "Non-Voting Shares". Only the holders of "Voting Shares" shall be allowed to cast votes concerning Shareholder business as defined in the Corporation's Articles of Incorporation, its By-Laws, and Florida Statute 607. et seq. This section shall not prevent holders of "Non-Voting" shares from their rights under Article X of these Articles of Incorporation."
