The name of the corporation is DIVERSIFIED RISK CONSULTANTS, INC.

ARTICLE TEN - INDEMNIFICATION

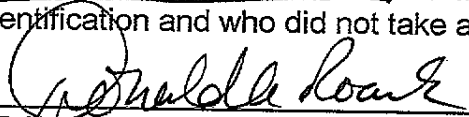
