I, the undersigned, hereby make the within Articles of Incorporation for the purpose of becoming incorporated and being a corporation be virtue of the laws of the State of Florida under the following proposed charter:

#### ARTICLE I - NAME/ADDRESS

The name of this corporation shall be <u>VAP Enterprises</u>, <u>Inc.</u> and its business shall be carried on in the State of Florida and such other states and foreign countries as may be agreed upon, and its principal place of business shall be 651 River Village Way, Tarpon Springs, Florida 34689 or such other place as from time to time is designated.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence unless sooner terminated by operation of law or voluntary dissolution in the manner prescribed by law.

# ARTICLE III - PURPOSE


