

Articles of Incorporation

American Quick-Cash Centers, Inc.

ARTICLE I

We hereby associate to form a for profit stock Corporation under the provisions of Chapter 607 of the Florida Statutes, and hereby adopt the following Articles of Incorporation. The Name of the Corporation shall be:

American Quick-Cash Centers, Inc.

The purpose or purposes for which the Corporation is organized are: to manufacture, purchase or otherwise acquire, own, mortgage, pledge, sell, import, export assign and transfer, or otherwise dispose of, to invest, trade, deal in and deal with goods, wares, services, merchandise and real and personal property of every class and description.






