# ARTICLES OF INCORPORATION Oof Active Payroll Service, Inc.

The undersigned person acting as incorporator of a corporation organized under the laws of Florida, hereby adopt the following Articles of Incorporation:

#### ARTICLE I CORPORATE NAME

The name of this corporation is Active Payroll Service, Inc.

### ARTICLE II INITIAL PRINCIPAL OFFICE

#### ARTICLE III SHARES

The total number of shares which the corporation shall have authority to <u>issue</u> is 300 shares with a <u>par value</u> of \$100.00 per share.

The purpose of the corporation is to engage in any lawful activity permitted by the laws of this state.

#### ARTICLE VI DIRECTORS

After the initial <u>board of directors</u>, the board shall consist of such number of directors as shall be determined by the shareholders from time to time at each annual meeting at which directors are to be elected.

#### ARTICLE VII LIABILITY OF DIRECTORS

To the fullest extent permitted by law, no director of this corporation shall be personally <u>liable</u> to the corporation or its shareholders for monetary damages for <u>breach</u> of any duty owed to the corporation or its shareholders, except that a director may be held personally liable for () breaches of the duty of loyalty, (ii) acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) declaration of unlawful dividends or unlawful stock repurchases or redemptions, or (iv) a <u>transaction</u> from which the director derives an improper personal benefit.

Any director or officer who is involved in <u>litigation</u> or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.

## ARTICLE VIII OTHER PROVISIONS

<u>Preemptive Rights.</u> The corporation elects to have preemptive rights so that each <u>shareholder</u> has the right to <u>acquire</u> a proportional amount of any shares that are issued.

<u>Director or Officer Interest.</u> In the absence of <u>fraud</u>, no <u>transaction</u> between (a) this corporation and (b) any other <u>association</u>, corporation or any director or officer of this corporation individually, shall be affected by the fact that any director or officer of this corporation is individually a party to the transaction or is interested in or is a director or officer of such other association or corporation.

Stock Transfer Restriction. No shareholder of this corporation shall sell any shares of stock held by him or her in this corporation without first offering to sell such stock to the corporation on the same terms and conditions and at the price offered in good faith and in writing, by any proposed

purchaser. The written offer by such proposed purchaser shall be delivered to the corporation at the time the stock is offered to the corporation for sale. The corporation shall have the right to accept the offer any time within thirty (30) days from and after the date on which the offer is made to the shareholder and shall exercise the option to purchase by notifying the shareholder in writing. If the corporation shall not exercise its option to purchase the shares of stock, it shall notify the shareholder in writing within the thirty (30) day period and the shares may then be sold by the shareholder, but only to the proposed purchaser on the same terms and conditions as offered to the corporation, and only within thirty (30) days from and after the date on which the corporation declines to exercise its option.

Execution of Written Instruments. All instruments that are executed on behalf of the corporation which are acknowledged and which affect an interest in real estate shall be executed by the President or any Vice-President and the Secretary or Treasurer. All other instruments executed by the corporation, including a release of mortgage or lien, may be executed by the President or Vice-President. Notwithstanding the preceding provisions of this section, any written instrument may be executed by any officer(s) or agent(s) that are specifically designated by resolution of the board of directors.
