The undersigned incorporator, a natural person over the age of eighteen (18), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I - NAME

#### <u> ARTICLE II - PRINCIPAL OFFICE</u>

In the absence of fraud, no director or officer having such adverse interest shall be liable to this corporation or to any shareholder or creditor hereof, or to any other person, for any loss incurred by it under or by reason of such contract or transaction, nor shall any director or officer be accountable to the corporation for any gains or profits realized thereon.

#### ARTICLE IX
