Article I

The name of the corporation shall be:

Blinds Wholesale, inc.

Article II

The general powers, purpose and nature of the business to be transacted, promoted or carried on by this Corporation are as follows:

- A. ## ARTICLE III H99000006278

- A. The maximum number of shares of stock which this Corporation is authorized to have outstanding at any one time shall be 1500, shares of voting common stock, each share having a \$1.00 par value.
