TO ARTICLES OF INCORPORATION OF

The following provisions of the Articles of Incorporation of TPS ENTERPRISES, INC., a Florida corporation (hereinafter called "Corporation"), are amended in the following particulars:

1. The name of this Corporation is TPS Enterprises, Inc.
2. An Amendment to Article I of the Articles of Incorporation has been adopted pursuant to Florida Statute §607.1003 (1993), to change the name of the Corporation. As amended, Article I now reads:

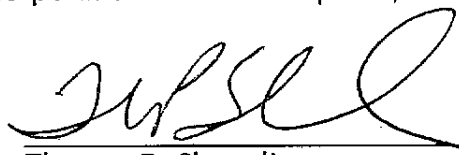
ARTICLE I.

NAME AND PLACE OF BUSINESS

Section 1.1 Name and Place of Business. The name of this corporation is JAXPARK.COM, INC., with its principal place of business at 2423 Rogero Road, Jacksonville, Florida 32211.

3. The above amendment to Articles of Incorporation shall be effective as of the filing date with the Secretary of State.
4. The foregoing amendment to Articles of Incorporation of TPS Enterprises, Inc. was adopted by the Corporation by virtue of unanimous Shareholder and Director consent, pursuant to Florida Statutes §§ 607.0704 and 607.0821, on September 20, 1999.
