ARTICLE ONE

The name of the corporation is SWARTOUT MASONRY, INC. The principal address of the corporation is: 2981 Windswept Drive, Suite #106, Lantana, Florida 33462.

ARTICLE TWO

The period of its duration is perpetual.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
