



RESOLVED, that the form of the stock certificate, a specimen copy of which follows this Consent, is hereby approved as the stock certificate to evidence stock, and be it further



Stock of the Corporation for a cash purchase price of \$1.00 (One Dollar) per share, and upon receipts by the Corporation of the full consideration payable by such subscriber for his shares of Common stock of the Corporation, the proper officers of the Corporation are authorized, empowered and directed to execute, issue and deliver to such subscriber a certificate for the appropriate number of shares of the Corporation's Common Stock, which stock, when so issued, shall be deemed fully paid and nonassessable; and be it further
