CERTIFICATE OF INCORPORATION OF

FLORIDA COAST EXPRESS, INC.

For the purpose of forming a corporation for profit under the general incorporation laws of the State of Florida, it is respectfully requested of the Secretary of State the approvation such incorporation under the following Articles.

ARTICLE 1
